Called the meeting to order at 9:31 am and asked Judy Strouth to give the audit report dated April 3, 2025 for Fiscal year 4/1/2024 - 3/31/2025

The Audit Committee examined the financial records (cash receipts, disbursements, and bank reconciliations). All available cash receipts were verified. All cash disbursements were examined and matched to documentation supporting each disbursement. Check disbursements were verified to bank statements and QuickBooks financial records. This audit was not designed to detect any fraudulent activity. Instead, the audit was conducted to determine that the HOA Treasurer follows proper accounting procedures and has adequate proper internal controls in place regarding the receipts and disbursements. No evidence of misappropriated funds or fraudulent activity was detected and the HOA Treasurer satisfactorily answered all questions raised during our audit.

The Audit Committee commended the HOA Treasurer, Joseph Gormley, for his excellent performance of accurate internal controls and proper accounting procedures. Treasurer's reports given at HOA meeting were concise and accurate. Mr. Gormley meticulously strived to streamline the process, consolidate the number of accounts, and effectively eliminate the possibility of any errors or chance of fraudulent activity, and the Audit Committee thanked him for that.

The current Audit Committee agreed to continue as requested by the Board.

<u>Legal Update:</u> Dot Theriault

NO action has been taken on our pending law suit. Wynne's last response was filed a day late.

Reports are coming to the attention of our board that the eviction notices have increased in two other parks. Appear to be aggressive and excessive.

Water Update: Bob Heslop

Cathy Townsend has been invited to attend our Annual Membership Meeting April 30th to give an update on the status of the transfer on water system to the county. Fabio has been appointed the Park Manager and Mike is no longer here.

Vice President Report: Dot Theriault
