**Letter from The H.O.A. President**

Please allow me to cover what seems to be major issues as seen on Facebook pages and those which have been the reason for many phone calls and face to face discussion.

The first, obviously, would be countless terrifying eviction threats resulting from what many consider overly aggressive, excessive and invasive home inspections. It seems we all agree that establishing and maintaining high community standards is in the best interest of our community. We all want a community we can take pride in. High standards make us comfortable and protects our home values and enhance our ability to enjoy friends, neighbors and community events. There are strong beliefs that these excessive inspections and threats are being used to punish residents because of the pending lawsuit which does not appear to be going their way. I wish I could tell you they are or are not. I cannot.

What I may say is that in less than 2 weeks since I have been back from the north, I have had no less than 6 people tell me that they are fed up and are going to sell their homes and move anywhere else. I have heard the same from folks living in Fairways and other Spanish Lakes Communities. The tornados and general economic conditions have caused high inventories of home for sale have created a buyers' market. This puts downward pressure on housing values and makes moving difficult. Knowing that a big part of the Wynne business involves building and selling both new and manufactured homes, I can't imagine they would shoot themselves in the foot by driving people away. Your HOA board members have met with them over these issues without compromise. We will keep trying.

The water issue seems like a dead end as far as the county is concerned. We have asked Representative Trabulsy to pursue financing through money left over from the federal government Milton relief and although it's a long shot there could be a chance. We will let you know when we know.

Pat Clymer is no longer our Rec Director. We would like everyone to join us not only to thank Pat for all her help and hard work, but to welcome Judy and Carol as Co Directors. We are certain they will do a great job.

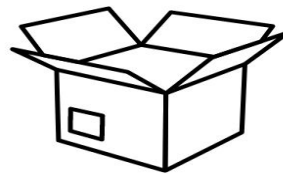

CALL them first to schedule the pickup: 800-775-8387.

The boxes or bags should be placed outside where the driver can see them before 8:00 a.m. They pick up between 8:00 a.m. and 5:00 p.m. Rain or Shine.

1. Pick Up Every Monday in Fort Pierce. Can leave up to 5 boxes or 5 bags of books and DVDs.
2. You must call them to schedule a pickup ahead 1-800-775-8387
3. Label your donations "VVA Pickup", so their driver will know what to pickup.
4. They pick up "Rain or Shine"
